The Islamic Republic of Afghanistan has received financing from the World Bank toward the cost of the **Afghanistan Second Skills Development Project (ASDPPII)**, and intends to apply part of the proceeds toward payments under the contract for “**Procurement of IT equipment**”. For this Contract the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank’s Disbursement Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.

Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers” **August 2016 Revised November 2017 and August 2018** (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations.
