Avicenna Non-Profit University

According to Decree No. 46 of the national constitution and the higher education requirements for private universities, and following all other regulations of the Ministry, the university was established and registered in 2010 AD as a non-profit university, officially starting its operations.

Avicenna University is the first non-profit university in Afghanistan, officially registered with the Ministry of Higher Education and established in 2010 AD. Students currently study in six faculties and sixteen fields at this university. The faculties of Avicenna University include Political Science, Law, Social Science, Economy and Management, Engineering, and Computer Science. Students also study at the master's level in the fields of International Law, Criminal Law and Criminal Science, and Public and Private Law.

Despite having permanent academic trained cadres and specialized management, Avicenna University's inclusive library, modern laboratory, and equipped computer labs are reasons for stability in the future. As a non-profit unit of higher education, Avicenna University provides affordable and high-quality education, currently with a positive financial balance, aiming to implement a program to support students and decrease education costs.

With a decade of higher education experience, Avicenna University prides itself on complying with all regulations and laws of the Ministry of Higher Education. It plays a crucial role in the academic and cultural construction of the country and strives to train specialized and academic generations for the country.

Initial Regulations

Base

Support for implementing the new strategic plan of TVET-A by Avicenna University (Kabul Branch) includes increasing accessibility, improving the quality of education, promoting and developing short-term vocational education, and effective management.

Goals

1. Providing opportunities for TVET-A graduates to enter Avicenna non-profit university with an education discount.
2. Holding capacity building programs to enhance the knowledge of TVET-A's teachers and administrative staff.
3. Conducting joint useful academic research and projects.
4. Planning programs for short-term vocational education.

Avicenna Non-profit University Accountabilities

According to this agreement, Avicenna non-profit university is accountable for committing to the following:

1. Absorbing introduced students with a 50% discount for 2 years (4 semesters) or 4 years (8 semesters) for a bachelor's degree in their favorite fields. The discount is only applicable for students who earn a 75% score each semester. If a student cannot earn 75% of the score, the discount for that semester will be concealed.
2. When the authority introduces more than 20 students, the university must accept one student for a bachelor's degree for free.
3. When the number of introduced students increase to more than 25 students, based on need academic seminars and workshops for the awareness of teachers and staff must be held at TVET-A or Avicenna University and must have appreciation letters.
4. Entrance of Managers and staffs of TVET-A with a 35% discount at the master's degree level.
5. Making opportunities for educating TVET-A students at Avicenna University if possible.
6. If the leadership of Avicenna non-profitable University changes, the university is committed to following the articles of this agreement.
