#### **Preface:**

However, individual challenges cannot be solved by merely describing the importance of Technical and Vocational Education. # **Base of the Agreement:**

This agreement is a formal document of mutual cooperation to gain joint objectives in education, technical and vocational training, and professional development. It aims to establish the Afghanistan Industrial Institute to develop the industrial sector of the country, signed by both sides.

In this agreement, the following abbreviations and expressions mean:

- 1. Authority: Technical and Vocational Education and Training Authority
- 2. Organization: Mission Mind Organization (MMO)
- 3. Both sides: Technical and Vocational Education and Training Authority and Mission Mind Organization (MMO)
- 4. Institute: Afghanistan Industrial Institute, which is planned to be established recently.

#### Goals:

- 1. Conduct a comprehensive survey of the industrial sector
- 2. Establish an industrial institute in Afghanistan
- 3. Hold industrial meetings with the coordination of the authority to strengthen the interim industry
- 4. Implement the basic proposals of "stay-in-Afghanistan" with technical and vocational education
- 5. Standardize the industrial sector of Afghanistan

# **Description of Institute:**

- 1. Name of the Institute: Industrial Institute of Afghanistan
- 2. Fields: based on survey
- 3. Capacity: based on needs and abilities
- 4. Locations: industrial parks and in favor of both sides
- 5. Category: Technical and Industrial
- 6. Education Period: from three months to three years

# **Both Sides Responsibilities:**

## **Responsibilities of the Authority:**

Based on this agreement, the authority has the following responsibilities:

- 1. Survey industrial sectors with the help of the organization
- 2. Create technical and vocational fields based on survey information to eliminate the needs of the industrial sector
- 3. Cooperate and support meetings and technical workshops held by the organization

- 4. Monitor the implementation of programs related to this agreement
- 5. Prepare, develop, and print the educational curriculum of the institute with support from the organization.

### **Responsibilities of the Organization:**

Based on this agreement, Mission Mind Organization has the following responsibilities:

- 1. Cooperate in surveying technical and vocational fields related to the industrial sector
- 2. Provide ordinary technical and financial support for the institute
- 3. Offer free educational services from the institute
- 4. Build capacity for teachers and staff related to industrial fields
- 5. Prepare and print raw materials and educational materials including books
- 6. The organization is responsible for presenting its financial reports to the authority quarterly and yearly.
